As directed by Section 216.181(11), Florida Statutes, the Legislative Budget Commission (LBC) is required to conduct meetings at least on a quarterly basis and is charged, among other things, with approving changes in the amounts appropriated from state trust funds in excess of \$1 million. This threshold is a cumulative amount that requires state agencies to request LBC approval even for nominal amounts after the \$1 million threshold has been reached. The \$1 million threshold has not been adjusted since its initial passage in law in 2001. A more practical approach would increase the threshold to at least \$2 million. Additionally, provisions in Chapter 216 could be enacted to allow the Governor to approve budget amendments, after a 14-day legislative consultation, if an LBC meeting does not occur within the required three months period. Both actions would allow for a more efficient processing of budget amendments. OPB provides a statewide function by reviewing all budget amendments and assisting agencies as needed in their compilation. LBC budget amendment review and evaluation involves not only OPB and Executive Office staff, but also external agency management/budget staff and Legislative members and staff. Therefore, a defined, defendable cost savings that included both internal and external factors to the agency was not determinable at the time of this review. Any cost savings by revision of Section 216.181, F.S., would be directed back to the Office of Policy and Budget.

The Manufactured Housing and Mobile Home Mitigation and Enhancement Program requires the mitigation or enhancement of manufactured or mobile homes to include but not be limited to problems

associated with weakened trusses, studs, and other structural components caused by wood rot or termite damage; site-built additions; or tie-down systems and other issues deemed appropriate by TCC, the Federation of Manufactured Home Owners of Florida, the Florida Manufactured Housing Association and the Department of Highway Safety and Motor Vehicles. Another component of the program is to perform education and outreach to owners of the benefits of the program. The objective of this program is to not only mitigate windstorm damage but to provide discounts, credits, reductions in deductibles, or other rate differentials for owners insured through the Citizen's Property Insurance Corporation and increased availability of insurance products to owners of manufactured or mobile homes. Annually, a report is to be submitted to the Governor, President of the Senate, and Speaker of the House of Representatives by Tallahassee Community College as to the number of homes that have taken advantage of the program, the types of enhancements and improvements made and whether there has been an increase in the insurance products available. Historically, the reports have not reflected any information regarding increased availability of insurance products. In addition, Citizen's Property Insurance currently does not offer any wind mitigation discounts for mobile homes. THE PRIORITY NUMBER RELATES SPECIFICALLY TO THE DIVISION OF EMERGENCY MANAGEMENT.

Eligible activities could include, but not limited to, hurricane roof tie down, hurricane shuttering, and wind reinforcement of garage doors. In addition, these residences may be eligible for discounts from their insurance carriers for the wind mitigation action. Section 215.559, Florida Statutes, requires that 10% of the funding received from the Florida Hurricane Catastrophe Fund be provided to the Florida International University center dedicated to hurricane research to develop a preliminary work plan approved by the advisory council to eliminate the state and local barriers to upgrade existing mobile homes and communities, research and develop a program for the recycling of existing older mobile homes, and support programs of research and development relating to hurricane loss reduction devices and techniques for site-built residences. Currently, the university receives \$700,000 but on average only spends 85% of the funding. THIS PRIORITY NUMBER RELATES SPECIFICALLY TO THE DIVISION OF EMERGENCY MANAGEMENT.
