The Department of State, Office of the Secretary and Division of Administrative Services, request a fund shift of one position in the amount of \$89,923 to general revenue from the federal grants trust fund. This request is year one of a multi-year appropriation request to transfer current expenditures provided under Help America Vote Act (HAVA) funding to general revenue. The HAVA funds have been and continue to be the key funding source for the Florida Voter Registration System and the Division activities' supporting that system. However, HAVA funds are projected to be depleted during FY 2021. Future state general revenue funds will have to offset and support the costs associated with continuing program administration once HAVA funds are exhausted.

The Help America Vote Act (HAVA) of 2002 imposed a number of new requirements on states relating to voter registration including the creation of a statewide voter registration system, voting systems, provisional ballot voting and other federal election administration activities, beginning in 2006. Florida received federal funds support to implement HAVA directly and indirectly. The HAVA State Plan reflects the State's actual and projected use of HAVA monies. Some HAVA funds are passed through the State to the counties to assist in poll worker training, voter education, accessibility for voters with disabilities, to implement subsequent legislation like the Military and Overseas Voter Empowerment (MOVE) Act such as the absentee ballot status tracking system, and to upgrade voting systems.

At this time, the HAVA program administration entails the following major 4 areas:

- (1) HAVA funds are used for the continuous maintenance and operation of the state's Florida Voter Registration System (FVRS) implemented in 2006.
- (2) Since the launch of FVRS in 2006, the Division intakes voter registration applications and verifies, in conjunction with the Florida Department of Highway Safety and Motor Vehicles, the personal identifying information needed to complete a voter's registration.
- (3) The State's role to ensure accurate voter rolls has also expanded exponentially. The Division dedicates a significant number of staff and resources to conduct eligibility maintenance activities, i.e., identifying duplicate registrations and potentially ineligible voters to forward to individual county supervisors of elections who initiate notice and removal processes.
- (4) Finally, HAVA funds are also used to support the Bureau of Voting Systems Certification which conducts voting system certification and examines election-related peripherals such as online ballot delivery and post-election voting system audit systems.

The Department of State, Office of the Secretary and Division of Administrative Services, requests \$500,000 nonrecurring funding from general revenue for litigation expenses in order to acquire legal representation for lawsuits related to elections and other Departmental litigation. The Department has limited legal staff and resources, which makes it difficult for the Office of the General Counsel internally to handle protracted litigation or litigation pending in venues outside Leon County without the aid of outside counsel. The Florida Department of Legal Affairs represents the Department in many of these situations unless its workload precludes taking additional cases or unless there is a conflict. In turn, in some cases it is necessary to obtain outside counsel and subject matter specialists to assist elections litigation and other Departmental issues. At times, multiple outside lawyers are needed simultaneously when there is a significant number of cases in which the Department is involved and when there is an urgency to prepare cases for almost immediate hearings and appeals. In recent years, especially in presidential election years, the Department has been involved in a large number of time-intensive, short-deadline cases, and the resources required to effectively handle the litigation duties have necessitated hiring outside counsel. Year 2016 is a presidential election year, and historically, presidential election years have been especially litigious for the Department.

The Department of State, Division of Administrative Services, request a fund shift of seven positions in the amount of \$477,439 to general revenue from the federal grants trust fund. This request is year one of a multi-year appropriation request to transfer current expenditures provided under Help America Vote Act (HAVA) funding to general revenue. The HAVA funds have been and continue to be the key funding source for the Florida Voter Registration System and the Division activities' supporting that system. However, HAVA funds are projected to be depleted during FY 2021. Future state general revenue funds will have to offset and support the costs associated with continuing program administration once HAVA funds are exhausted.

The Help America Vote Act (HAVA) of 2002 imposed a number of new requirements on states relating to voter registration including the creation of a statewide voter registration system, voting systems, provisional ballot voting and other federal election administration activities, beginning in 2006. Florida received federal funds support to implement HAVA

directly and indirectly. The HAVA State Plan reflects the State's actual and projected use of HAVA monies. Some HAVA funds are passed through the State to the counties to assist in poll worker training, voter education, accessibility for voters with disabilities, to implement subsequent legislation like the Military and Overseas Voter Empowerment (MOVE) Act such as the absentee ballot status tracking system, and to upgrade voting systems.

At this time, the HAVA program administration entails the following major 4 areas:

- (1) HAVA funds are used for the continuous maintenance and operation of the state's Florida Voter Registration System (FVRS) implemented in 2006.
- (2) Since the launch of FVRS in 2006, the Division intakes voter registration applications and verifies, in conjunction with the Florida Department of Highway Safety and Motor Vehicles, the personal identifying information needed to complete a voter's registration.
- (3) The State's role to ensure accurate voter rolls has also expanded exponentially. The Division dedicates a significant number of staff and resources to conduct eligibility maintenance activities, i.e., identifying duplicate registrations and potentially ineligible voters to forward to individual county supervisors of elections who initiate notice and removal processes.
- (4) Finally, HAVA funds are also used to support the Bureau of Voting Systems Certification which conducts voting system certification and examines election-related peripherals such as online ballot delivery and post-election voting system audit systems.

This is in addition to the \$2,000,000 provided in recurring federal grants trust fund authority, bringing the total funding amount to \$4,000,000 for FY 2016-17. The additional \$2,000,000 will provide critically needed funds to counties for increased voter education and other election administration activities for the 2016 Primary and General Elections. The funds primarily will be used for the following activities: mailing and publishing sample ballots and voter information cards; advertising and publishing materials regarding voting procedures, voting rights, or voting technology; voting system demonstrations; poll worker training stipends and training materials; voter guides; maintaining online or web-based absentee ballot-request, ballot-tracking and precinct-finder systems; purchasing (subject to approval or certification by the Department of State) of software or hardware technology that enhances or facilitates the delivery of absentee ballots, the casting and counting of valid votes, voting system audits, or recount processes, and the certification of accurate and complete election results; and other approved activities. These funds are distributed and monitored in accordance with executed State-county memoranda of agreement relating to the request, receipt and use of federal monies under the Help America Vote Act (HAVA). The appropriation and distribution of these funds helps to satisfy the requirement under the State's HAVA Plan adopted pursuant to section 254 of HAVA to help fund voter education, election official education and training, and poll worker training, and other election administration activities relating to elections in which a federal office appears on the ballot. The Department of State, Division of Historical Resources, requests \$25,000 realignment of expenses recurring authority to be transferred to establish an operating capital outlay (OCO) category from the land acquisition trust fund for furniture and equipment purchases. The Department of State, Division of Historical Resources, requests \$125,000 in nonrecurring authority for design services related to the future expansion of the Archaeological Collection Facility from the land acquisition trust fund. Chapter 267, Florida Statutes, requires the Division to provide leadership in the preservation of the state's historic resources and to administer state-owned or state-controlled resources.

During the last three years, the state's Archaeological Collection has been re-located from Northwood Centre to three separate buildings at Mission San Luis. Compact shelving was purchased and installed providing additional shelf space insufficient to meet the Division's projected needs. This estimate was based on analysis of twelve years of data from the Florida Master Site File, the Bureau of Archaeological Research's Collection, and the Compliance and Review Section in the Bureau of Historic Preservation. The Department of State, Division of Historical Resources, requests \$268,535 nonrecurring funding from the land acquisition trust fund for Historic Preservation Grants (Small-Matching Historic Preservation Grants), awarding up to \$50,000 as recommended by peer review. This is in addition to the \$1,500,000 provided in recurring general revenue, bringing the total program amount to \$1,768,535. Funding for the Historic Preservation Grants (Small-Matching Historic Preservation Grants) is authorized in section 267.0617, Florida Statutes, and administered by 1T-39.001, Florida Administrative Code. There are six project types applicants can apply for through the grant program including: Acquisition and Development; Survey and Planning; Community Education; National Register Nominations; Historical Markers; Main Street Start Ups; and Special Statewide Projects. Departments or agencies of the state, including universities, cities, counties and other units of local government, and not-for-profit organizations, can apply through this program.

Historic Preservation Small Matching grants preserve Florida's historical and archaeological resources through restorations and rehabilitation of historic buildings and structures, as well as through survey and evaluation of historic and archaeological resources and education about Florida history. Restoration and rehabilitation projects under this program are a proven stimulus package that boosts both the economy and quality of life. It draws millions of tourists to towns and communities that offer authentic experiences and a sense of history generating state and local taxes. Preservation grants create jobs directly in the restoration of older buildings and indirectly in the entrepreneurial opportunities that restored buildings provide to downtown districts. Preservation is also environmentally responsible. Reusing existing buildings depletes fewer natural resources, preserves greenways and conserves the energy originally required to extract, process, manufacture, transport and install building materials, and reduces landfill

The Department of State, Division of Library and Information Services, requests \$1,000,000 nonrecurring funding from general revenue for the Library Cooperative grant program. The Library Cooperative grant program provides funding to five multi-type library cooperatives to assist them in meeting the educational and informational needs of Florida residents through the sharing of materials among libraries for the development of library service. To cost effectively meet the needs of their clientele, Florida libraries share material and information. This is done using a statewide catalog of Florida library materials that currently includes holdings records for over 25 million items. Library materials included in the statewide catalog are findable by the public and are shared between libraries through informal and structured arrangements.

Library Cooperative grant funds are used by the multi-type library cooperatives to provide required maintenance of the statewide catalog of library materials. The multi-type library cooperatives facilitate the initial loading of each library's holdings into the statewide catalog, updates and revisions to the union listing of serial holdings, and the ongoing maintenance of local library holdings. The multi-type library cooperatives coordinate training of library staff responsible for maintaining a library's information within the statewide catalog and for locating and retrieving materials from other libraries using the statewide catalog. Funding for Library Cooperative grants is authorized in sections 257.40-257.42, Florida Statutes, and administered by 1B-2.011, Florida Administrative Code. The funding formula originally allocated the grant funds among six multi-type library cooperatives. When one dissolved in 2010, the counties in that region were reassigned to other cooperatives. The formula was modified to provide additional funding to the cooperatives that took on additional counties. Library cooperatives are 501 3(c), tax-exempt membership organizations.

The Department of State, Division of Library and Information Services, requests \$701,166 recurring funding from general revenue for the State Aid to Libraries grant program. This is in addition to the \$22,298,834 provided in recurring general revenue, bringing the total funding amount to \$23,000,000. The Division of Library and Information Services requests funding for State Aid to Libraries as provided in section 257.17-19, Florida Statutes, and administered by 1B-2.011, Florida Administrative Code. The additional grant funds will be used to support operations in Florida's 555 public libraries. The State Aid program is designed to assure that all Florida residents have access to free public library service. The program also encourages increased local support for public library service. The state must guarantee through its Maintenance of Effort \$20,217,536 in order to continue to receive its full allotment of federal Library Services and Technology Act grant funds.

The State Aid to Libraries program supports three types of grants:

Operating Grants: All qualified counties are eligible to receive up to \$0.25 on every \$1.00 of local funds spent for the operation and maintenance of a library. Grants are prorated if the program is not fully funded.

Equalization Grants: These grants are made available to those counties that qualify for an Operating Grant and that have limited local tax resources. The formula for distribution of these grants is based on fiscal capacity, effort, and need. The total for Equalization Grants may not exceed 15 percent of the appropriation. Grants are prorated if the program is not funded at or above \$31,999,233 or if libraries qualify for more than 10 percent of the amount required to fund the equalization grants.

Multicounty Library Grants: These grants are made available to provide support to libraries that qualify for Operating Grants and that choose to join together to offer library service to their residents in a more cost-effective manner. To qualify, a multicounty library must serve a combined population of at least 50,000 and serve two or more counties, at least one of which qualifies for an Equalization Grant. The grants have two components: a base grant and a match on the first \$1 million in local expenditures. These grants are not prorated.

State Aid funds are used to provide all residents free access to library services including increasing hours of operation and number of staff at library facilities, enhancing the library's collections of print and electronic books and supporting citizens' technology needs. The 2013 Return on Investment study found that for every dollar invested in

This program is designed to support the general program activities of an organization engaged in conducting, creating, producing, presenting, staging, or sponsoring multiple cultural exhibits, performances, events, or providing cultural services during the grant period. Grantees match awards dollar for dollar with cash and in-kind contributions. Applicants may apply for one Cultural and Museum Grant (General Program Support) or one Culture Builds Florida Grant (Specific Cultural Projects), but may not apply for both. In a recent study conducted, 65% of visitors to Florida participated in cultural activities.

Eligible applications are reviewed in an open competitive process by peer review panels. Panel recommendations are then reviewed by the Florida Council on Arts and Culture and forwarded to the Secretary of State for approval. Subject to Legislative appropriation, all applications approved by the Secretary of State will be awarded their full requested fund amount or award amounts will be determined by a score-based formula that proportionally distributes the appropriation.
