The Department of State, Division of Historical Resources, requests \$25,000 realignment of expenses recurring authority to be transferred to establish an operating capital outlay (OCO) category from the land acquisition trust fund for furniture and equipment purchases. This appropriation will enable the Division to purchase furniture or equipment that exceeds \$1,000 per unit threshold under the expense category.

The Division of Historical Resources does not currently have an OCO appropriation in general revenue. The Division does have an OCO appropriation of \$15,625 in the federal grants trust fund, but expenditures allocated to that appropriation must be related to a federally funded grant project or contract. As a result, the Division currently has no ability to use state funds for equipment and furniture purchases exceeding \$1,000. This appropriation is needed to assist in furnishing and equipping historical sites managed by the Division.

Employees in this section will have various specific duties and also will be trained on all of the Division's services. The employees will be able to respond to the vast majority of questions that the public may have about services, functions, processing procedures and times, fees, and general filing requirements.

The Department of State, Division of Cultural Affairs, requests \$25,000 realignment of expenses recurring authority to be transferred to establish a contracted services category from the land acquisition trust fund. The current allocation of \$90,709 in general revenue authority is insufficient for the needs of the Museum of Florida History and the Cultural Affairs section. The Museum requires its own contracted services category for the many activities unique to a museum such as security, maintenance and shipping of artifacts and exhibits, and artist services. Costs for the maintenance of two historic properties use a major portion of the current general revenue budget leaving little if any for the normal contractual needs of the Division.
