Priority #1 - Over 95% of the State Attorney's Office, Third Judicial Circuit's General Revenue budget authority is in Salaries and Benefits. The target reduction of 10% that this agency is asked to consider is equal to \$475,117 from General Revenue and another \$70,828 from trust funds. A reduction of this amount would require that this agency create an additional 8 vacancies. The authorized FTE for this office is 70. Due to insufficient General Revenue funding for Salaries, this office is unable to fill all authorized positions. Currently, there are 3 vacancies and the 10% budget reduction would cause another 8 vacancies (4 attorneys and 4 legal assistants). The required calculations are based on a salary of \$49,000 for the attorneys and \$31,000 for the legal assistants, along with the required benefits for all 8 positions. Most likely, Misdemeanor prosecutions would come to a near halt as this office just wouldn't have an adequate staff. Remaining staff would be assigned to prosecute the most serious crimes.

This reduction would bring the total vacant positions to 11 which is a 15.7% reduction of staff over the currently authorized number. The caseload in the Third Judicial Circuit would remain the same. Practically speaking, the attorney positions which would most likely become vacant are Misdemeanor attorney positions. Those caseloads would be shifted to Felony attorneys who are already carrying the 5th largest caseloads in the state (based on FY 16-17 case counts provided in the LRPP). Although this circuit is the 19th smallest circuit in the state, the violent crime rate in the circuit was number 2 in the state just a couple of years ago. This statistic represents the seriousness of having trained prosecutors on staff to handle these cases in a swift and just manner. The remaining attorneys could not take on the additional workload while maintaining their felony caseloads. This would result in a significant degradation in the quality of prosecutions which in turn would negatively impact public safety. The impact to this circuit would be dreadful.

Priority #1 - Salaries and benefits account for 94% of the total budget authority for the State Attorney's Office, Fourth Judicial Circuit. To achieve a \$2,717,689 target reduction in salaries and benefits, our circuit would be required to create an additional 48.79 vacant positions through attrition and layoffs. The number of additional vacant positions is calculated by an average salary and benefits of \$51,612.29.

The State Attorney's Office, Fourth Judicial Circuit has 58 vacant positions to compensate for the cuts that our circuit has already taken. A further reduction of current staff would bring the total vacancies to 106.64 (58+48.79 = 106.79). This would reduce the number of total approved positions from 364 to 257.21. The State Attorney's Office, Fourth Judicial Circuit's case load remains the same. This reduction in workforce would translate into an unmanageable workload for the remaining staff, and would result in a significant degradation in the quality of prosecution and negatively impact public safety in Duval, Clay, and Nassau Counties.

The State Attorney's Office, Fourth Judicial Circuit relies on additional assistance from our OPS employees. OPS would be reduced by cutting the number of students that are hired to assist with projects. Hiring these students to help with projects allows our full-time staff to focus on other duties. Reducing our OPS appropriation by \$75,000 would greatly impact our office.

The State Attorney's Office, Fourth Judicial Circuit receives \$11,404 for salary incentive payments for our investigators CJIP pay. The approximate cost for FY-19 is \$25,200; therefore, our circuit already has a deficit of \$13,796.

This issue impacts the following activities of this agency: Felony Prosecution, Misdemeanor Prosecution, Juvenile Prosecution, Investigations, Witness Coordination, and Civil Prosecution.

 Priority #1 - Because 95% of our total budget is in Salaries & Benefits, to achieve the target reduction we would be required to create 59 additional vacant positions. (This is calculated on an average salary of \$45,194 at a cost of \$60,108.). We are presently carrying 49 vacant FTEs to compensate for cuts already imposed. Another 59 would bring our total vacancies up to 108 representing a 23.5% reduction in our work force. This increase of 59 new vacancies represents a 14.4% reduction in our remaining workforce.

Our caseload remains essentially the same so a new 14.4% reduction in our workforce would thus translate to a 14.4% increase in workload for the remaining staff. This would result in degradation in the quality of prosecutions which in turn would negatively impact public safety.

Priority #1 - The General Revenue budget of the Office of the State Attorney, Eighth Judicial Circuit has already been reduced by \$1,426,793 from fiscal year 2007-2008 to 2012-2013 and our FTE have been reduced from 146 to 133 from FY 2007-2008 to FY 2017-2018. Since 95 % of this office's overall budget is the salaries and benefits of our employees, to achieve a \$973,087 target reduction, this agency would be required to create 16 additional vacant prosecutorial positions through attrition and lay-offs. The State Attorney, Eighth Judicial Circuit is presently carrying 10.5 vacant FTE to compensate for cuts we have already taken as described above. Another 16 would bring our vacancies up to 39.5, which equates to a 27% overall reduction, translating to an increase in workload for the remaining staff. This reduction would result in a significant degradation in the quality of prosecutions which in turn would negatively impact public safety. These reductions would further cripple this agency from performing the essential functions of its Constitutional and Statutory mandate to pursue justice for the State of Florida and to protect the safety of its citizens.

(This is calculated on an average salary of \$56,400 at a cost of \$81,900. We are presently carrying 212 filled FTEs to carry out the duties and responsibilities of the office. A cut of 21 positions creates a 10% reduction in the work force. The caseload remains the same. A 10% reduction in our work force translates into a 10% increase in workload for the remaining staff. This would result in a significant degradation in the quality of prosecutions which in turn would NEGATIVELY IMPACT PUBLIC SAFETY.

The State Attorney's Office for the Eleventh Circuit (SAO 11) experienced 19% in budget cuts between October 1, 2007 and July 1, 2018, resulting in the loss of sixty-three (63) positions and \$9.7 Million. Since 98% of our budget is for salaries and benefits, these cuts overwhelmingly affected staffing. The cuts have resulted in many unfilled positions remaining vacant, which in turn have increased the caseload per Assistant State Attorney and significantly increased the workload of our support staff. Trust funded positions were authorized in 2008-2009 in part to offset some of the cuts in General Revenue, but funding for those positions depends on revenue accumulated over time in trust funds. There is no assurance that funding for these positions can be sustained into the future, further affecting already depleted staffing. An additional 10% reduction will result in substantial employee layoffs and adversely affect our ability to perform the mandated constitutional responsibilities of this office.

Funding for the SAO 11's Child Support Enforcement Trust Fund is received through a cost reimbursable contract with the Department of Revenue to provide child support enforcement services in Miami-Dade County. Child Support Enforcement is a Title VD program where the Federal government provides 66% matching funds to the State's 34%. Every \$1 reduction in state funding will result in an additional loss of \$2 to the program in federal funding, and adversely affect the state's ability to provide quality child support services to our community. Staff reductions will result in a decline in the number of child support orders issued and enforced, and could ultimately result in greater costs to the state to provide public assistance in cases where there is insufficient staff to enforce compliance with child support obligations.

This issue impacts the following activities of this agency: Felony Prosecution, Misdemeanor Prosecution, Juvenile Prosecution, Investigations, Witness Coordination, Child Support Enforcement and Civil Prosecution.

Priority #1 - 95.86% of this office's FY 18/19 budget is allocated to Salaries and Benefits. Our office does not have excess funds in any category in which we currently receive funding/authority. As a result, achieving an overall 10% budget reduction would require that the ENTIRE reduction be made in Salaries and Benefits. We have no choice but to indicate this reduction scenario as Priority #1, because there would be no other priority that would come close to the extremely negative impact such a reduction would have on our office's ability to prosecute crime.

In order to achieve a \$2,692,567 (10%) target reduction, our office would be required to create approximately 37.45 additional vacant positions through layoffs and attrition. This is calculated on an average salary of \$53,648.14 and a total cost with benefits of \$71,888.50. As of July 2, 2018, this office is carrying 54.40 vacant FTEs to compensate for budget cuts taken in previous years. An additional 37.45 FTEs would bring total vacancies to 91.85 (92 rounded). This would represent a 68.84% additional reduction in work force. During previous budget cuts, as well as during this target reduction, caseload in our office has remained consistent with previous years, with only a minimal decrease. A 68.84% additional reduction in work force would translate into a 68.84% increase in workload for the remaining staff. The practical implications for prosecutions and public safety would be dire. Fewer prosecutors handling larger caseloads would not only bog down the criminal justice system, but would also negatively affect public safety. Recidivism would likely increase without the deterrent of an effective and efficient criminal justice system. Diversion programs would suffer without the necessary investment of time and resources, and violent criminals would be emboldened, all of which would make our community less safe and less able to enforce Florida law.

Priority #1 - Because 95% of the State Attorney's Office budget is in Salaries and Benefits, to achieve a \$925,321 target reduction, the State Attorney's Office, Fourteenth Judicial Circuit, would be required to create 12.5 additional vacant positions through attrition and lay-offs. (This is calculated on an average salary of \$49,280 at a cost of \$74,123).

The State Attorney's Office, Fourteenth Judicial Circuit, is currently carrying 9.5 vacant FTEs to compensate for cuts we have already taken. Another 12.5 would bring the total vacancies up to 22. This would represent a reduction in the work force.

Caseload remains the same. A reduction in work force would translate into an increase in workload for the remaining staff. This will result in a significant degradation in the quality of prosecutions which in turn would negatively impact public safety.

Priority #1 - A 10% reduction would necessitate a corresponding reduction in personnel. This office spends approximately 24 million on Salaries and Benefits and 1.5 million on all other operations, insurance, service charges, training etc. Therefore, the 10% reduction would result in a loss of \$2,538,269 in Salaries and Benefits. This reduction would result in laying off 36 attorneys or twice as many support staff employees or some combination. This is calculated on an average salary of \$46,157 at a cost of \$70,394. Alternatively, a 10% reduction in employee salaries would address this reduction. For the average 3 year attorney that would result in a loss of \$5,548 or roughly \$463 per month.

This type of reduction would require the closure of special prosecution units such as "White collar", "Public Corruption", "Special Victims", "Organized Crime" and "Homicide". The remaining attorneys would assume those workload extensive, high profile cases into a trial load that is already over 200 referrals for felony attorneys and 1700 referrals for misdemeanor attorneys. The primary obligation is to cover all court appearances and address all criminal arrests in the county. The reduction would require the office to reprioritize all arrests placing our greatest resources in the felony division and reducing or dismissing certain misdemeanors and delinquencies to enable the remaining prosecutors to manage the larger caseloads this would create. Victim and witness contact and coordination would be reduced or eliminated.

Priority #1 - Impact of Reduction: Due to the fact that 98% of our total budget is in the Salaries & Benefits category, to achieve this target reduction this agency will be required to create twelve (12) new, vacant positions through attrition and layoffs (calculated using a current average salary rate of \$55,619 at an average cost of \$88,806). The State Attorney, 19th Circuit presently carries an average of thirty-four (34) vacant positions to compensate for the reductions this agency has experienced over the past nine years. To create another twelve (12) vacant positions will bring us to a total of forty-six (46) vacant positions in this agency. This represents more than a 28% reduction in our total work force. This action will severely limit our ability to successfully prosecute cases and perform essential, constitutional functions in the Nineteenth Judicial Circuit. This action will also negatively impact public safety because of the State's impaired representation in both criminal and civil courts in this circuit.

Priority #1 - Currently, 96% of our total budget is in Salaries & Benefits, to achieve the \$2,309,462 targeted reduction would require our agency to lay off 30 staff members to meet this goal. This calculation is based off of an average Salary & Benefits of \$77,062 for the 20th Judicial Circuit.

At the present time we are carrying 21 vacant FTEs to compensate for cuts we have already taken. Another 30 vacancies would bring the total vacant FTE to 51, this represents a 10.38% reduction in our work force.

With our caseload remaining constant, a 10.38% reduction in our work force would translate into a significant increase in workload for the remaining staff. The consequences of this action would be the degradation of the quality of prosecution services provided and ultimately it would negatively affect public safety and our ability to meet statutory requirements.

A reduction in the funding for Grants and Donations (GDTF) would impair our agency's ability to adhere or meet our contractual obligations. Reductions within Trust Fund would limit our ability to spend the cash generated through the state authorized trust funds.

The Office of Public Defender, Third Circuit covers 7 counties and has 3 offices. The Third Circuit is geographically one of the largest circuits in the state. General Revenue Salaries & benefits represents 96.7% of the total FY 18-19 General Revenue appropriations. However, to balance and zero the GR S&B account at FYE 17-18 required the equivalent of an additional 5.1% of GR S&B from trust fund appropriations to balance the account to zero.

The 4.0 FTE reduction required to meet the 10% budget reduction will create a substantial hardship on the employees of PD03 and impact the delivery of comprehensive indigent criminal defense services to our clients. The target reduction figure for the Fifth Judicial Circuit Public Defender's office is \$999,123 (\$743,544 from GR and a combined total of \$255,580 from our TF accounts). Monthly salary projections for FY18-19 (when fully staffed and no staff on authorized leave without pay) average \$793,500. A reduction of \$934,155 in Salaries and benefits alone would require our circuit to close the Citrus County location, terminating 14 employees, to cover \$915,032 in salaries. The additional loss in revenue of \$121,532 would require furloughing employees in our other county locations. This closure would cause a ripple effect in reduced Trust Fund collections in both Grants and Donations, which is funded by reimbursement contracts for hours worked by our IT department and in our Indigent Criminal Defense Trust Fund, which is funded by application fees, and court costs associated with representation. During this closure, new case assignments in Citrus County (which in FY17-18 was 3,518, an increase of 209 cases over the prior year) would need to be outsourced to private counsel potentially costing the state \$2,638,500.

Priority #1 - This office has recurring General Revenue for operating expenses of less than \$345,000. Much of this fund is committed to the operational requirements of the office. The only category to look to for a recurring reduction of \$1,020,812 would be Salaries & Benefits, from General Revenue and Indigent Criminal Defense Trust Fund (ICDTF). A recurring reduction of this amount would require a reduction of 15 attorneys, which is 25% of our attorney workforce. As indigent defendants have a constitutional right to counsel, a 25% reduction in workforce could result in an equal percentage of cases which would have to be represented by other counsel. This shift in workload could be as much as 6,800 cases. If the average costs to the State for alternative representation was \$500, this would result in a new cost to the State of \$3,400,000. This Public Defender office represents the most cost effective manner of delivering indigent representation. The service this office renders is a constitutional obligation of the State. Any reduction of funding that shifts workload to another source of representation can only result in an increase in costs.

To shift cases assigned to the Public Defender because of budget reductions would require a change in Florida Statute 27.5303(1)(d), which currently provides that "In no case shall the court approve a withdrawal by the public defender or criminal conflict and civil regional counsel based solely upon inadequacy of funding or excess workload of the public defender or regional counsel."

The United States Supreme Court's decision in Hurst v. Florida caused a backlog of over 400 death eligible cases that are now being processed through the criminal justice system. If only 50% of those cases are assigned to the CCRCs, the increase in caseload would be overwhelming, necessitating staffing at current levels. A reduction of \$355,000 would cause CCRC-M to reduce its staff by five (5) attorney positions, thereby affecting the ability of CCRC-M to timely process cases and meet time standards set by the Florida Supreme Court, as well as create an inability to meet its legislatively created performance measures. Additionally, if the CCRCs are unable to handle the anticipated increased caseloads due to a reduction in current staffing levels, the private registry of attorneys would be assigned new cases, which represents a cost shift, not a cost savings to the state since registry attorneys are compensated by state funds.

Furthermore, CCRC-M's recent purchase and migration to a case management system requires additional OPS employees to perform the duties of scanning current case information into a system that will allow employees the ability to input, track and maintain vital data which was unavailable, or at the least, difficult to locate. OPS employees are more cost efficient as they are not entitled to all the benefits associated with full-time employees. The OPS reduction of (\$28,317) represents approximately 40% of our current OPS appropriation and would hamper CCRC-M's ability to continue with the special projects associated with scanning large quantities of documents and migrating to the new system.

CCRC-South anticipates a substantial increase in its caseload during FY 19-20, and for several years thereafter, due to the backlog of cases making their way through the system after court decisions in Hurst v. Florida and Hurst v. State. The public records process, promulgated by Rule 3.582 Florida Rules of Criminal Procedure, creates an obligation for every party associated with a death penalty case to provide public records to post-conviction counsel. Each case usually generates approximately 40 bankers boxes of records which must be scanned into CCRC-South's document management system for review by the legal team assigned to the case. Document scanning systems save valuable office space and taxpayer dollars, since documents do not have to be physically stored on site and can be reviewed via computers.

In fact, the General Revenue reduction in this category has been reduced 49.8% compared to fiscal year 2001-2002. The Case Related Cost category pays for all litigation costs as cases proceed through the post-conviction process. A decrease of \$104,612 in this category (28.8% of the total schedule VIIIIB-2 target reduction) would hamper CCRC-S's ability to process new cases anticipated during fiscal year 19-20 as a result of the court decisions in Hurst v. Florida and Hurst v. State, as well as the large backlog of death penalty cases put on hold while those cases were being decided. Rule 3.851, Florida Rules of Criminal Procedure and Title 28 United States Code Section 2254 require that a post-conviction motion be filed within one year from the time a death sentenced defendant's conviction and sentence becomes final. If a post-conviction defendant does not comply with that time frame he/she may be forever barred from pursuing claims in the state and federal courts. During that one year time frame, the CCRCs must collect all the records associated with a case, interview witnesses, hire experts, if required, and file final post-conviction pleadings which comply with Rule 3.851. A large percentage of costs associated with the post-conviction appeals process occur during that one year period.

Priority #1 - A ten percent (10%) reduction in the Office of Criminal Conflict and Civil Regional Counsel, Fifth Region's (RC5) appropriation would result in the closure of two (2) of eight (8) RC5 offices. The specific offices are: the Osceola County Office and the Brevard County Office. Twelve (12) full time assistant regional counsel attorneys and four (4) full time legal assistants would lose their employment. The closures of these two offices would result in approximately 1,241 cases in Osceola County and 1,936 cases in Brevard County having to be reassigned to private court appointed attorneys to be billed and paid pursuant to the rates established in Florida Statutes. The cases in Brevard and Osceola Counties represent RC5's third and fourth highest caseload out of a total of thirteen (13) counties. The 3,177 cases that would go to private court appointed attorneys include criminal, dependency, probate, all other civil matters, and appeals. This required shifting of expenses to private court appointed attorneys would create a significant increase in the amount that the Justice Administration Commission would have to pay in attorney fees and in due process costs.
