The Department of State, Office of the Secretary and the Division of Administrative Services, requests \$266,813 (\$258,561 recurring and \$8,252 nonrecurring) in budget authority in the General Revenue Fund for 2.00 Full Time Equivalent (FTE) Senior Attorney positions to assist with litigation caseload in the Office of the General Counsel.

These two Senior Attorney positions are being requested at a salary rate above the base rate of \$80,000 and \$95,000 respectively. This is necessary in order to recruit and retain the level of legal expertise to represent the Department and assist with the litigation caseload.

There is a limited number of legal staff within the Department and in recent years, especially in presidential election years, the Department has been involved in a substantial amount of litigation with the vast majority of these cases involving Florida statutes and constitutional questions.

The Department of State, Office of the Secretary and the Division of Administrative Services, requests \$1,000,000 in nonrecurring budget authority in the General Revenue Fund for litigation expenses in order to acquire legal representation for lawsuits related to elections and other Departmental litigation. The amount requested is based on the Department's year-to-date spending on the defense of litigation.

The Department has limited legal staff and resources, which makes it difficult for the Office of the General Counsel internally to handle protracted litigation or litigation pending in venues outside Leon County without the aid of outside counsel. The Florida Department of Legal Affairs represents the Department in many of these situations unless its workload precludes taking additional cases or unless there is a conflict. In turn, in some cases it is necessary to obtain outside counsel and subject matter specialists to assist elections litigation and other Departmental issues. At times, multiple outside lawyers are needed simultaneously when there is a significant number of cases in which the Department is involved and when there is an urgency to prepare cases for almost immediate hearings and appeals. In recent years, especially in presidential election years, the Department has been involved in a substantial amount of litigation with the vast majority of these cases involving Florida statutes and constitutional questions.

The Department of State, Division of Administrative Services, requests \$1,292,221 (\$1,250,961 recurring and \$41,260 nonrecurring) in budget authority from the General Revenue Fund and 10.00 Full Time Equivalent (FTE) positions to establish a Cyber Security Bureau.

The 10.00 FTE positions include:

1. Chief Information Security Officer [Bureau Chief] (\$95,000)
2. Certified Information Systems Security Professional (\$85,000)
3. Network Architect (\$75,000)
4. Certified Secure Software Lifecycle Professional (\$75,000)
5. Program Manager for Cyber Navigators (\$90,000)
6. Cyber Navigator (\$85,000)
7. Cyber Navigator (\$85,000)
8. Cyber Navigator (\$85,000)
9. Cyber Navigator (\$85,000)
10. Cyber Navigator (\$85,000)

These ten cybersecurity positions are being requested at a salary rate above the base rate ranging between \$95,000 and \$75,000 respectively. This is necessary in order to recruit and retain the level of cybersecurity expertise required to protect the Department and offer support to Supervisors of Elections around the state.

As part of the Joint Elections Security Initiative (JESI) with the Governor's Office, cyber security and securing Florida's elections is a top priority for the Department and these cyber-security positions will bolster the current staff and provide an even stronger presence against cyber threats in the future. With the increasing frequency of cybercrime around the world, it is critically important that the Department continue to be proactive against this growing threat. By increasing cyber security staff, the Department will be able to better protect the integrity of its mission critical systems and provide further calibration and assistance with our Supervisor of Elections partners.

in improved operational efficiencies, an enhanced filers experience and provide more transparency in candidate and campaign finance activities.

The current system is not compatible with current web browsers and various forms of modern technology including some laptop computers, cell phones and tablets. In addition, it does not have the capacity to handle the continually increasing volume of users (filers, media, organizations, and citizens desiring to view campaign finance records). Its software languages and operating systems are obsolete.

A legislatively directed study in 2013 elicited the Department of State's proposed requirements for a mandatory statewide electronic campaign finance reporting system and included proposed in-house and vendor-developed options in response to a formal Request for Information to develop, design, test, provide training and implement a comprehensive statewide EFS that included both state filers and county and municipal filers. The Department of State, Division of Elections, requests \$1,806,061 in recurring budget authority in the General Revenue Fund to support budget authority that was originally provided by the Help America Vote Act(HAVA).

The Help America Vote Act (HAVA) funds have been a key funding source for supporting election related activities. In order to continue these activities this funding and budget authority is necessary as HAVA funding is projected to be depleted.

The need for this budget authority and funding is critical to maintain operations in the Division of Elections. As an example, \$604,437 is requested in the Expenses category which represents 45% of the appropriation in the Expenses category for Fiscal Year 2019-2020 of \$1,321,505. The Expenses category covers operational cost such as rent, telephones and annual license costs for Information Technology support.

In addition, without this budget authority the Voting Systems Assistance category will not be funded in Fiscal Year 2020-2021, which is requested in the amount of \$525,000 in this issue. This budget authority was used in Fiscal Year 2018-2019 to provide small counties with limited fiscal resources with upgraded technology to support their voting systems. These funds would be used similarly in Fiscal Year 2020-2021.

The request also provides \$319,284 for staffing under the Other Personal Services (OPS) category and \$300,058 for the Contracted Services category. Without this request the OPS category will be left with a base budget of \$88,514, which would impact the division's ability to keep voter rolls current and accurate. The funding of this issue within the Contracted Services category would also ensure continued support for operations of Florida Voter Registration System.

The Department of State, Division of Elections, requests \$1,375,000 (\$1,300,000 nonrecurring and \$75,000 recurring) budget authority from the General Revenue Fund for list maintenance services and voter outreach.

As of 2019, Florida law (Section 98.075(2), Florida Statutes) gives the Department of State the option to become a member of a nongovernmental entity whose sole purpose is voter registration information sharing for the purpose of list maintenance. Once the State joins, the Department of State is required to report to Governor and Legislature on December 31 of every year the number of voters removed as a result of data obtained from the entity and the reason for the removal. An example of such a nongovernmental entity is the Electronic Registration Information Center (ERIC). ERIC is a non-profit organization formed in 2012 with the sole mission of assisting states to improve the accuracy of America's voter rolls and increase access to voter registration for all eligible citizens. ERIC membership entitles its member states (consisting of elections officials only) to have their state's voter rolls and driver license information records analyzed for duplicate registrations within and across state, deceased status, in-state and out-of-state address changes. As a condition of membership, the state is required to conduct a voter registration mail drive to all eligible but unregistered voters before the next upcoming general election following initial membership. The list of eligible but unregistered voters is derived from information that will be provided by the Florida Department of Highway Safety and Motor Vehicles who is also an integral stakeholder in the successful implementation of this program.

The Department of State, Division of Historical Resources, requests \$973,025 in nonrecurring budget authority in the Federal Grants Trust Fund to be reappropriated for the allocation received in response to Hurricanes Harvey, Irma, and Maria (HIM) Emergency Supplemental Historic Preservation Fund (ESHPPF).

A total of \$5,932,724 was awarded to the division by the National Park Service (NPS) May 31, 2019. The purpose of this grant is to fund historic preservation projects providing relief to damages in areas that received a major disaster declaration pursuant to the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 USC 5121 et seq.) as a result of Hurricane Irma. In FY 2019-2020, \$4,959,699 will be used for fixed capital historic preservation subgrants for repairs to historic properties directly related to damage from Hurricane Irma and for surveys of historic districts and archaeological sites to determine the degree of damage that occurred from Hurricane Irma.

The request to reappropriate budget authority is for the continued development of historic resource disaster planning documents for statewide usage, for two OPS staff members to assist in managing subgrants, and costs associated with travel to subgrant project locations. The Department of State, Division of Historical Resources, is requesting \$10,301,287 in nonrecurring Land Acquisition Trust Fund authority for the construction of an artifact curation facility that can accommodate the growing collection of Florida's precious historical objects and allow us to share these objects with the public. The current curation facility is nearly at capacity, and the Division can no longer accommodate the accession of new artifacts without compromising professional curation standards. The amount requested has been provided by a study completed in 2017.

The Department of State, Division of Library and Information Services, requests \$8,927,220 in nonrecurring budget authority in the General Revenue Fund for the State Aid to Libraries grant program. This amount is being requested in nonrecurring authority to offset the VIIIB-2 Reduction amount from the recurring \$17,304,072 appropriated from the Division's operating budget bringing the total funding amount to \$21,468,993 if the reduction was taken. This amount is the average of the State Aid appropriation from the past three years. This amount is needed for the State Aid to Libraries grant program in order for the Division to meet its Maintenance of Effort (MOE) required by Institute of Museum and Library Services (IMLS) in the amount of \$23,180,603.

The Division requests funding for State Aid to Libraries as provided in s. 257.17-19, F.S., and administered by 1B-2.011, Florida Administrative Code. The additional grant funds will be used to support operations in Florida's 568 public libraries. The State Aid program is designed to assure that all Florida residents have access to free public library service. The program also encourages increased local support for public library service.

The State Aid to Libraries program supports three types of grants:

Operating Grants: All qualified counties are eligible to receive up to \$0.25 on every \$1.00 of local funds spent for the operation and maintenance of a library. Grants are prorated if the program is not fully funded.

Equalization Grants: These grants are made available to those counties that qualify for an Operating Grant and that have limited local tax resources. The formula for distribution of these grants is based on fiscal capacity, effort, and need. The total for Equalization Grants may not exceed 15 percent of the appropriation. Grants are prorated if the program is not funded at or above \$31,999,233 or if libraries qualify for more than 10 percent of the amount required to fund the Equalization Grants.

Multicounty Library Grants: These grants are made available to provide support to libraries that qualify for Operating Grants and that choose to join together to offer library service to their residents in a more cost-effective manner. To qualify, a multicounty library must serve a combined population of at least 50,000 and serve two or more counties, at least one of which qualifies for an Equalization Grant.

The grants have two components: a base grant and a match on the first \$1 million in local expenditures. These grants are not prorated. State Aid funds are used to provide all residents free access to library services including increasing hours of operation and number of staff at library facilities, enhancing the library's collections of print and electronic books and supporting citizens' technology needs.

Funding for the Cultural and Museum grant program (General Program Support) is authorized in s. 265.286, F.S., and administered by 1T-1.036, Florida Administrative Code. This program is designed to support the general program activities of an organization engaged in conducting, creating, producing, presenting, staging, or sponsoring multiple cultural exhibits, performances, events, or providing cultural services during the grant period. Grantees match awards dollar for dollar with cash and in-kind contributions. Applicants may apply for one Cultural and Museum Grant (General Program Support) or one Culture Builds Florida Grant (Specific Cultural Projects), but may not apply for both.

Eligible applications are reviewed in an open competitive process by peer review panels. Panel recommendations are then reviewed by the Florida Council on Arts and Culture and forwarded to the Secretary of State for approval. Subject to Legislative appropriation, all applications approved by the Secretary of State will be awarded their full requested fund amount or award amounts will be determined by a score-based formula that proportionally distributes the appropriation.

Funding for the Culture Builds Florida grant program (Specific Cultural Projects) is authorized in s. 265.286, F.S., and administered by 1T-1.036, Florida Administrative Code. To achieve equitable distribution of state funds, applicants may apply for one Cultural and Museum Grant (General Program Support) or one Culture Builds Florida Grant (Specific Cultural Projects), but may not apply for both. Grantees must match grant awards dollar for dollar and 25% of total project costs may be in-kind contributions. Organizations in a Rural Economic Development Initiative (REDI) designated county are eligible for a waiver of the cash match requirement. Eligible applications for all specific cultural project categories are reviewed in an open competitive process by peer review panels comprised of professionals knowledgeable in the various disciplines and are limited to one grant per annual grant cycle. Panel recommendations are then reviewed by the Florida Council on Arts and Culture and forwarded to the Secretary of State for approval. Project grants shall be funded at full request by score until all appropriated funds are depleted.
