 ISSUE TITLE: Supplemental Appropriations for Legal Representation

ISSUE SUMMARY: The General Counsel's Office handles most litigation with in-house resources (attorneys from the General Counsel's Office). On rare occasions when in-house resources may not be sufficient, the Agency hires the State of Florida's Attorney General's Office ("AGO") to provide legal representation. This occurs primarily with complex class action lawsuits involving Medicaid issues brought against the Agency. In these cases, the Agency is often a co-defendant with other state agencies such as: Department of Children & Families ("DCF"); Department of Health ("DOH"); Agency for Persons with Disabilities ("APD"); and Department of Elder Affairs ("DOEA"). Experience has shown that it is cost effective for the AGO to defend the multiple agencies, with the agencies splitting the cost of representation. The General Counsel's budget pays for invoices from the AGO. In addition to the AGO, private outside counsel must at times be hired. Private outside counsel costs are usually paid by the Division of Medicaid from Contracted Services.

ISSUE DETAIL: Without appropriate legal representation, the Agency will be subject to losing lawsuits which could potentially cost the State of Florida anywhere from millions to billions of dollars. Because of the rise in complex lawsuits and without obtaining additional funding, the General Counsel's Office will be unable to hire the AGO to defend the Agency in these lawsuits which cannot be handled in-house. Over the past three years, payments to the AGO have nearly doubled as indicated in the following data from the last three fiscal years ("FY"):

The majority of these fees have been for two major class action lawsuits: Long v. Benson and Florida Pediatric Society v. Benson. The increase in fees may be attributable to the following factors: (1) although fees charged by the AGO are considerably lower than those of a private law firm, the AGO's rates have increased twice in the past five years, the latest occurring in 2007; (2) changes to federal discovery rules have resulted in an upswing in the costs of discovery;

and, (3) a tight state budget has limited the ability of the Agency for Health Care Administration ("the Agency") to settle these lawsuits in the earlier stages which prolongs the litigation and consequently the costs.

Although the services of the AGO have been terminated for the Long v. Benson lawsuit, representation in Florida Pediatric Society v. Benson is ongoing. A recent estimate from the AGO to complete representation through trial is \$499,657.48. This amount alone is more than the entire General Counsel's OPS budget for the last fiscal year. There is also a possibility that the other state agencies involved in this lawsuit may be dismissed, requiring the Agency to take over the entire cost of representation. If at any time additional federal class action lawsuits are filed against the Agency, our current budget will not be sufficient to cover the costs of appropriate and necessary representation.

BUDGET SUMMARY: The additional funds the General Counsel's Office is requesting in order to continue to hire the AGO for complex lawsuits are calculated as follows:

 ISSUE TITLE: Funding for Increase in Rent in Miami Area Office

ISSUE SUMMARY: This request is for the Agency for Health Care Administration, Miami Area Office lease contract that began March 1, 2009. Budget is needed to pay the dollar increase in rent for the lease obligation as of July 1, 2010. This lease houses AHCA, Miami Area 11 Offices consisting of Medicaid, Health Quality Assurance, Health Quality Assurance Plans and Construction, Inspector General Medicaid Program Integrity, and General Counsel Offices.

ISSUE DETAIL: This is one of the larger area offices in the Agency and the programs mentioned above could not operate if this lease was not funded. The Miami Area Office is vital to the overall operation and mission of the Agency in furnishing better health care for all Floridians through the Division of Medicaid and Health Quality Assurance. This lease was bid using the Invitation to Negotiate process and using the professional tenant broker CB Richard Ellis contracted under the Department of Management Services.

This issue allows the following programs to operate: Medicaid and Health Quality Assurance programs which include Long Term Care Facilities, Adult Living Facilities, HMO's, Hospitals, and others that operate in Monroe and Dade Counties. Without this lease, there would be no place to house staff to carry out the functions of Medicaid and Health Quality Assurance. Through the bid process, this space was obtained and needs to be funded to carry out the Agency operations and ensure that other health care facilities furnish the needed health care in these counties and reduce fraud.

ISSUE TITLE: Consultant Services to Conduct Medicaid Information Technology Architecture (MITA) Assessment

ISSUE SUMMARY: This issue requests funding to allow Medicaid to contract with a consultant to perform the Medicaid Information Technology Architecture (MITA) State Self Assessment. MITA is an initiative of the federal Centers for Medicare and Medicaid Services (CMS) and is currently in the rule-making process at the federal level, which will mandate the MITA concepts for state Medicaid systems. MITA provides a common business and technology vision for state Medicaid programs that emphasizes goals such as: a patient-centric view not constrained by organizational barriers; interoperability between state Medicaid programs within and across states, web-based integration, software reusability and the integration of public health data.

ISSUE DETAIL: CMS requires that state Medicaid programs conduct a State Self-Assessment based on MITA concepts to accompany Advanced Planning Documents (APD) to CMS to obtain Federal Financial Participation (FFP) enhanced match for Medicaid fiscal agent operations. Without this assessment, CMS will not grant enhanced federal financial participation for the Medicaid system. Because this is a very specialized and technical assessment, the services of a consultant with specific skill-sets are needed to assist the Medicaid program with the assessment. Activities include:

- development of the Concept of Operations;
- identification of stakeholders and enablers;
- identification of major data exchanges that will be affected by the transformation plans;
- assist the state in determining the level of maturity in the business operations and system(s) desired in the 5 and 10 year transition plans; and
- develop an analysis of the level of effort and resources required to achieve the 5 and 10 year transition plans.

This MITA assessment is required to review Medicaid's readiness to become aligned to the continually changing designs/models that CMS creates. This model will change year to year. If the MITA assessment is not conducted then CMS will not approve any future APDs, Contract Amendments, and will not continue to provide enhanced FFP for Medicaid Management Information System (MMIS) endeavors. This MITA assessment for which funding is needed is to set the base for Medicaid's continuous MITA alignment efforts.

BUDGET SUMMARY: Funding of the consultant contract will be 90% FFP and 10% state funds. The requested amount for this budget request was calculated for nine consultant analysts using a "mean" rate of three vendors on the DMS State Term Contracts list for Management Consulting Services. Usual funding for MMIS is 75% federal and 25% state. Without this initiative the funding for MMIS could revert to 50% federal and 50% state. Based on the FY 2009-10 budget for MMIS operations, without the enhanced FFP the Agency estimates it will lose over \$8 million in federal funding and the state would have to make up this amount.

This issue requests funding to allow Medicaid to contract with an outside independent auditor, specializing in audit of health facility entities, to audit DSH payments. States that do not complete the audit of fiscal 2005 and 2006 by December 31, 2010 and meet the criteria provided in the federal rule jeopardize funding under the program for qualified providers.

ISSUE DETAIL: The final rule from the federal regulations (42 CFR 447 and 455) sets forth the data elements necessary to comply with the requirements of Section 1923(j) of the Social Security Act (Act) related to auditing and reporting of DSH payments under State Medicaid programs. These requirements were added by Section 1001(d) of the Medicare Prescription Drug, Improvement, and Modernization Act of 2003 (MMA).

Section 1902(a)(13)(A)(iv) of the Act requires that States make Medicaid payment adjustments for hospitals that serve a disproportionate share of low-income patients with special needs. Section 1923 of the Act contains more specific requirements related to such DSH payments, including aggregate annual state-specific limits on Federal financial participation under Section 1923(f), and hospital-specific limits on DSH payments under Section 1923(g). Under those hospital specific limits, a hospital's DSH payments may not exceed the costs incurred by that hospital in furnishing services during the year to Medicaid patients and the uninsured, less other Medicaid payments made to the hospital, and payments made by uninsured patients. In addition, Section 1923(a)(2)(D) requires States to provide an annual report to the Secretary of Health and Human Services describing the payment adjustments made to each disproportionate share hospital. Section 1001(d) of the Medicare Prescription Drug, Improvement, and Modernization Act of 2003 (MMA)(Pub. L. 108-173, enacted on December 8, 2003) added Section 1923(j) to the Act to require States to report additional information about their DSH programs. Section 1923(j)(1) of the Act requires States to submit an annual report that includes the identification of each DSH facility that received a DSH payment under the state's Medicaid program in the preceding fiscal year and the amount of DSH payments paid to that hospital in the same year. Such other information as the Secretary of Health and Human Services determines necessary to ensure the appropriateness of DSH payments may be required.

States are required in section 1923(j)(2) to have their DSH payment programs independently audited and to submit the independent certified audit annually to the Secretary of Health and Human Services. The certified independent audit must verify the following:

- The extent to which hospitals in the state have reduced uncompensated care costs to reflect the total amount of claimed expenditures made under Section 1923 of the Act.
- DSH payments to each hospital comply with the applicable hospital-specific DSH payment limit.
- Only the uncompensated care costs of providing inpatient hospital and outpatient hospital services to Medicaid eligible individuals and uninsured individuals as described in Section 1923(g)(1)(A) of the Act are included in the calculation of the hospital-specific limits.
- The state included all Medicaid payments, including supplemental payments, in the calculation of such

hospital-specific limits.

- The state has separately documented and retained a record of all its costs under the Medicaid program, claimed expenditures under the Medicaid program, uninsured costs in determining payment adjustments under Section 1923 of the Act, and any payments made on behalf of the uninsured from payment adjustments under Section 1923 of the Act.

In addition to these reporting requirements, under Section 1923(j) of the Act, federal matching payments are contingent upon a State's submission of the annual DSH report and independent certified audit. Based on the FY 2009-10 budget for regular disproportionate share in the amount of \$246 million, without the federal matching payments the Agency estimates it will lose \$135 million in federal funding and the state and counties will have to make up this amount.

BUDGET SUMMARY: Funding of the audit for a year was estimated by examining the potential cost an outside independent auditor would charge to perform an audit of this nature.

ISSUE TITLE: Nursing Home Transition Case Managers

ISSUE SUMMARY: This issue requests funding to allow Medicaid to contract for nursing home transition case managers to assist with identifying individuals who wish to move from an institution to community settings, assessing their needs, and helping them make arrangements for community living.

ISSUE DETAIL: Individuals who reside in nursing facilities for more than a few weeks often need assistance if they are to move back home or to a less restrictive setting like an assisted living facility. For example, individuals may need help locating housing and household furnishings if their own home is no longer available. Even when Medicaid funded home and community based waiver services are available to help with activities essential to living in the community, a person may still need help making all the arrangements to move out. Without this help, individuals who otherwise could have safely lived in their own home or in the community may have to remain in this more restrictive and expensive institutional setting.

The contracted entity must have the capacity to work with adults of all ages and in all areas of the state. Transition case managers should possess expertise in transitioning individuals into the community; demonstrate expertise working with elders, individuals with disabilities and their families; familiarity with home and community-based services; the ability to assess, identify, network, and address gaps in community services; and a working knowledge of Medicaid, Medicare, Veterans Administration, and other health care insurance payers. The contracted entity must be capable of coordinating with AHCA, Department of Children and Families, Department of Health, and Department of Elder Affairs to supplement any transition efforts by their staff and by home and community based services waiver case managers.

This issue assumes a cost of \$60,000 annually per transition case manager, with one case manager for each of the 11 AHCA areas. This would be matched at the Medicaid administrative rate, so general revenue of \$330,000 would be needed. If each full time case manager carries an average caseload of 30 individuals for a maximum of six months, up to 660 individuals could be transitioned annually statewide at a cost of \$1,000 per transition.

This payment method may result in significant savings compared to what is currently being paid for the ADA waiver case

managers. The ADA waiver case managers for age 18-59 are paid by the Department of Children and Families and 60+ are paid by the Department of Elder Affairs with AHCA drawing down the federal share. They are currently being paid \$11.25 per 15 minute units with 32 units per day. At this payment rate for the same average caseload, the annual case management cost per case manager is \$93,600, or \$1,560 per transition. The contracted case managers proposed in this issue will be \$560 per transition cheaper than what is paid for the ADA waiver case managers. Based on estimates of the August 2009 Social Services Estimating Conference for SFY 2009-10, it is estimated that the cost for 660 individuals in a nursing home will cost a total of \$14,493,855. There will be an estimated total savings in the amount of \$28,307,661 for these individuals to be in a community setting rather than in a nursing home.
