This issue reduces critical funding which supports the operations of Camp Blanding Joint Training Center (CBJTC). The budgeted appropriation for salaries and benefits in the Camp Blanding Trust Fund s barely enough to meet end-of-year payroll. The department has submitted budget amendments, each year, requesting transfer of budget authority from other expenditure categories to salaries and benefits to meet year-end payroll. A reduction of funding, however minimal, will severely hinder our ability to pay our employees and may hinder Camp Blanding's capability to perform it's full time mission.

The impact of this reduction is Significant.
