ISSUE TITLE: Reduction to Contracted Legal Services

SUMMARY:

This issue reduces budget authority in the Contracted Legal Services appropriation category by 83%. The Contracted Legal Services appropriation category is used to contract for legal services to represent the department in various circuit and administrative court matters. Contracting for these services is critical to ensure the department receives adequate legal representation to effectively respond to lawsuits in conjunction with the existing Office of the General Counsel, which is staffed by three attorneys. Given the current workload in the office, and the specialized legal advice presently provided by outside counsel, the loss of this funding would create significant difficulties for the department.

ISSUE TITLE: Staff Reductions in Accounting

SUMMARY:

This recurring reduction eliminates 13 of the 15 positions in the Accounting Office. This reduction would significantly impact the department's ability to carry out its primary accounting functions, including:

- Accounts Payable: processing vendor, travel, purchasing card, and MyFloridaMarketPlace payments and effectively manage prompt payment compliance;
- Cash Management: daily cash and investment analysis, handling retailers' weekly sweep of bank accounts, and transferring profits to the Educational Enhancement Trust Fund (EETF); and
- Financial Reporting: calculating the transfer to the EETF accurately and timely and preparing monthly and annual financial statements required by law.
