Long Range Program Plan Approved Activity: Executive Direction and Support Services

This issue reduces funding by \$68,049 and eliminates two (2) full time equivalent positions in the Office of Performance Management as a result of service improvements effective January 1, 2011. Annualization of the reduction yields a total savings of \$136,097. This reduction is also included within a larger VIIIIB-2 issue for fiscal year 2011-12.

The Office of Performance Management is responsible for the establishment and reporting of performance metrics, strategic goals, objectives, and strategies. This office promotes and reviews customer service standards and recommendations for service improvements. This office also analyzes crash statistics and researches operational trends and issues, directs enterprise project and portfolio management including grants, and provides oversight for policy development and maintenance.

This issue proposed the elimination of two (2) positions that are assigned to the Service Improvement section. This section monitors and analyzes customer feedback, makes recommendations for improvement, assists other divisions in developing feedback instruments and implementing efficiencies, monitors and reports performance metrics and outcomes, serves as a consumer advocate for elevated customer complaints, and is responsible for the collection of data and accomplishments for designing and publishing quarterly and annual reports. By narrowing the focus of this office to internal efficiencies and monitoring and reporting on organizational performance, the elimination of two (2) positions can be accomplished. This issue is part of a larger issue included in the VIIIIB-2.

IMPACT TO THE PUBLIC: A reduction in customer service initiatives to track, advocate, and communicate objectives which focus on external efficiencies.

The Office of Performance Management is responsible for the establishment and reporting of performance metrics, strategic goals, objectives and strategies. The Grants Administration Office (GAO) was established as a centralized clearinghouse for all agency grant activities in order to establish better accountability and a more focused effort on the type of grant awards requested. This section is also responsible for identifying additional grant funding sources for support of Department initiatives.

A new database was recently established to streamline the grant routing and approval process. In addition, two of the

This issue reduces unnecessary SUNCOM telecommunications budget in the amount of \$139,917 in the Expenses category pursuant to Line Item #2179A, Chapter 2010-152, Laws of Florida and according to the Office of Policy and Budget agency addressed memorandums 11-008 and 11-017. This issue is also included in the VIIIB-2 reduction exercise.

The distribution of the recurring budget reduction appropriated in Administered Funds for SUNCOM services was posted to the Appropriations Ledger as of September 22, 2010. The reduction results from a reported accumulated surplus of funds by the Division of Telecommunications at the Department of Management Services due to efficiency improvements and increased utilization of SUNCOM services for the period July 1, 2008 through December 31, 2009. SUNCOM is providing price reductions and refunds for specified services as a result of the surplus. The reduced rates were effective January 1, 2010 followed by the return of excess funds collected by DMS, the implementation of the recurring budget reduction contained in Administered Funds, Specific Appropriation 2179A, in the Fiscal Year 2010-11 General Appropriations Act and the distribution of excess funds.

Long Range Program Plan Activity: Conduct Traffic Homicide Investigations

This issue reflects the reclassification of seventeen Law Enforcement Investigator I positions to Law Enforcement Officers resulting in an annual savings of \$67,593. This issue is also included in the VIIIB-2 exercise.

Traffic Homicide Investigators are law enforcement officers that have received specialized training in crash investigations. Traffic Homicide Investigators are responsible for conducting criminal investigations on fatal traffic crashes to determine if criminal negligence has occurred. These investigations consist of the initial on-scene investigations where vital physical evidence is identified, interpreted, and collected during the scene investigation using various technologies. The investigation continues with in-depth background investigations and post-crash vehicle inspections. If the investigation reveals criminal negligence, the investigator makes the appropriate criminal charges and presents the case to the State Attorney's Office.

Due to the reduction in traffic homicides in recent years, the Department can continue to conduct competent traffic homicide investigations with a lower number of traffic homicide investigators. This reduction will result in transferring additional cases to the remaining Traffic Homicide Investigations staff. If we see a significant growth in traffic homicide investigations in future years, the Department will submit a budget issue to increase investigation staffing. This issue is also included in the VIIIB-2 exercise.

This issue eliminates one (1) vacant Community Service Officer (CSO) position resulting in an annual savings of \$40,865. The Community Service Officer program consists of 22 CSO's and has been beneficial to FHP through their ability to respond to traffic crashes and assist disabled motorists. This allows Law Enforcement Officers to spend more time attending to more critical incidents and/or preventive patrol. The other benefits of the CSO program include lower personnel costs and shorter training periods as compared to the Law Enforcement Officer costs. In Fiscal Year 2009-10 Community Service Officers worked approximately 39,858 hours, resulting in 7,590 arrests, responding to 10,400 crashes and 5,703 motorists needing assistants.

This issue is also included in the VIII B-2 exercise for fiscal year 2011-12.

IMPACT TO THE PUBLIC: The impact upon the public would be a longer average response time and diminished law enforcement presence on the roads. Additionally, this will require troopers to investigate minor traffic crashes which are currently being investigated by the CSO's, resulting in a reduction of troopers' ability to conduct preventive patrol duties.

Long Range Program Plan Activity: Enforcement of Traffic Laws

This initiative reduced the Florida Highway Patrol's mandatory retraining costs through the implementation of online training for a portion of the required hours. This initiative resulted in an annual savings of \$35,823.

The 1,685 sworn members of the Florida Highway Patrol are required by the Criminal Justice and Standards Training Commission (CJSTC) to attend 40 hours of mandatory retraining every four years. The Florida Highway Patrol divides the four year training requirement into four, one year, cycles with 421 members attending training sessions each year. All training was previously conducted at the Florida Highway Patrol Training Academy in Havana, Florida. However, implementation of on-line training for 20 of the required mandatory 40 hours has resulted in an annual savings due to reduced travel and lodging expenses. The additional 20 hours of mandatory retraining cover critical high liability courses that cannot be taught online. This initiative reduces annual training cost in the amount of \$35,823. This issue is also included in the 8B-2 reduction exercise.

This issue is also included in the VIII B-2 exercise.

The distribution of the recurring budget reduction appropriated in Administered Funds for SUNCOM services was posted to the Appropriations Ledger as of September 22, 2010. The reduction results from a reported accumulated surplus of funds by the Division of Telecommunications at the Department of Management Services due to efficiency improvements and increased utilization of SUNCOM services for the period July 1, 2008 through December 31, 2009. SUNCOM is providing price reductions and refunds for specified services as a result of the surplus. The reduced rates were effective January 1, 2010 followed by the return of excess funds collected by DMS, the implementation of the recurring budget reduction contained in Administered Funds, Specific Appropriation 2179A, in the Fiscal Year 2010-11 General Appropriations Act and the distribution of excess funds.

This issue reduces unnecessary SUNCOM telecommunications budget in the amount of \$139,917 in the Expenses category pursuant to Line Item #2179A, Chapter 2010-152, Laws of Florida and according to the Office of Policy and Budget agency addressed memorandums 11-008 and 11-017. This issue is also included in the VIIIB-2 reduction exercise.

The distribution of the recurring budget reduction appropriated in Administered Funds for SUNCOM services was posted to the Appropriations Ledger as of September 22, 2010. The reduction results from a reported accumulated surplus of funds by the Division of Telecommunications at the Department of Management Services due to efficiency improvements and increased utilization of SUNCOM services for the period July 1, 2008 through December 31, 2009. SUNCOM is providing price reductions and refunds for specified services as a result of the surplus. This issue requests a nonrecurring salary and benefits reduction of \$950,000 within the Licenses, Titles and Regulations Program. Of this reduction, \$560,000 is requested in the Driver Licensure budget entity, \$140,000 is requested in the Identification and Control of Problem driver budget entity, and \$250,000 is requested in the Vehicle and Vessel Titles and Registrations budget entity.

Due to the outsourcing of driver licensing functions, numerous offices will be closing in the next few years. As an office transition is announced, personnel are frequently hired by the tax collectors many months prior to the actual transition. The positions cannot be refilled due to training time and the upcoming closure. This results in a non-recurring salary reduction. Recurring salary reductions related to office closures are included in the VIII B-2 exercise.

Due to lack of funding in the 2009-2010 fiscal year, hiring of critical positions was suspended. Mission critical positions in the Division of Motor Vehicles are now being filled, however, the recruitment, hiring and selection process has resulted in some nonrecurring salary savings in fiscal year 2010-11. Other recurring salary reduction options have

DESCRIPTION OF ACTIVITY TO BE REDUCED OR ELIMINATED:

This issue requests a nonrecurring salary and benefits reduction of \$950,000 within the Licenses, Titles and Regulations Program. Of this reduction, \$560,000 is requested in the Driver Licensure budget entity, \$140,000 is requested in the Identification and Control of Problem driver budget entity, and \$250,000 is requested in the Vehicle and Vessel Titles and Registrations budget entity.

Due to the outsourcing of driver licensing functions, numerous offices will be closing in the next few years. As an office transition is announced, personnel are frequently hired by the tax collectors many months prior to the actual transition. The positions cannot be refilled due to training time and the upcoming closure. This results in a non-recurring salary reduction. Recurring salary reductions related to office closures are included in the VIIIB-2 exercise.

Due to lack of funding in the 2009-2010 fiscal year, hiring of critical positions was suspended. Mission critical positions in the Division of Motor Vehicles are now being filled, however, the recruitment, hiring and selection process has resulted in some nonrecurring salary savings in fiscal year 2010-11. Other recurring salary reduction options have been included in the VIIIB-2 exercise.

This issue reduces unnecessary SUNCOM telecommunications budget in the amount of \$139,917 in the Expenses category pursuant to Line Item #2179A, Chapter 2010-152, Laws of Florida and according to the Office of Policy and Budget agency addressed memorandums 11-008 and 11-017. This issue is also included in the VIII B-2 reduction exercise.

The distribution of the recurring budget reduction appropriated in Administered Funds for SUNCOM services was posted to the Appropriations Ledger as of September 22, 2010. The reduction results from a reported accumulated surplus of funds by the Division of Telecommunications at the Department of Management Services due to efficiency improvements and increased utilization of SUNCOM services for the period July 1, 2008 through December 31, 2009. SUNCOM is providing price reductions and refunds for specified services as a result of the surplus. The reduced rates were effective January 1, 2010 followed by the return of excess funds collected by DMS, the implementation of the recurring budget reduction contained in Administered Funds, Specific Appropriation 2179A, in the Fiscal Year 2010-11 General Appropriations Act and the distribution of excess funds.

DESCRIPTION OF ACTIVITY TO BE REDUCED OR ELIMINATED:

Long Range Program Plan Approved Activity: Enforce Title and Registration Laws

This issue requests a nonrecurring salary and benefits reduction of \$950,000 within the Licenses, Titles and Regulations Program. Of this reduction, \$560,000 is requested in the Driver Licensure budget entity, \$140,000 is requested in the Identification and Control of Problem driver budget entity, and \$250,000 is requested in the Vehicle and Vessel Titles and Registrations budget entity.

Due to the outsourcing of driver licensing functions, numerous offices will be closing in the next few years. As an office transition is announced, personnel are frequently hired by the tax collectors many months prior to the actual transition. The positions cannot be refilled due to training time and the upcoming closure. This results in a non-recurring salary reduction. Recurring salary reductions related to office closures are included in the VIIIB-2 exercise.

Due to lack of funding in the 2009-2010 fiscal year, hiring of critical positions was suspended. Mission critical positions in the Division of Motor Vehicles are now being filled, however, the recruitment, hiring and selection process has resulted in some nonrecurring salary savings in fiscal year 2010-11. Other recurring salary reduction options have been included in the VIIIB-2 exercise.

This issue reduces unnecessary SUNCOM telecommunications budget in the amount of \$139,917 in the Expenses category pursuant to Line Item #2179A, Chapter 2010-152, Laws of Florida and according to the Office of Policy and Budget agency addressed memorandums 11-008 and 11-017. This issue is also included in the VIIIIB-2 reduction exercise.

The distribution of the recurring budget reduction appropriated in Administered Funds for SUNCOM services was posted to the Appropriations Ledger as of September 22, 2010. The reduction results from a reported accumulated surplus of funds by the Division of Telecommunications at the Department of Management Services due to efficiency improvements and increased utilization of SUNCOM services for the period July 1, 2008 through December 31, 2009. SUNCOM is providing price reductions and refunds for specified services as a result of the surplus. The reduced rates were effective January 1, 2010 followed by the return of excess funds collected by DMS, the implementation of the recurring budget reduction contained in Administered Funds, Specific Appropriation 2179A, in the Fiscal Year 2010-11 General Appropriations Act and
