The reduction of the clemency activity by 28.5 FTE's in FY 2011-12 will result in further increasing the pending case workload for this activity. While the Clemency function constitutes 46% of the agency's workload, Commission activities such as Parole, Conditional Release, Addiction Recovery, Control Release, Conditional Medical Release, and Seaport Security investigations all have statutorily mandated time frames, while the activity of Clemency is an executive function governed by Statute and Board Rule with no mandated statutory time-frames. There are currently 47 FTE's assigned to the clemency activity (whole or in part) of which 37 process clemency cases, conduct RCR eligibility reviews and clemency investigations. The remainder performs administrative and support functions for this activity. If reductions were to be made, the Commission would have no alternative but to make cuts in the clemency activity. The reduction of 28.5 FTE would result in 34,000 Level 1 RCR cases, 2,300 Level 2 RCR cases and 736 level 3 clemency cases not being completed.

NOTE: The 28.5 FTE's are based upon an average salary, average leave payout, and unemployment.
