The completion of this Schedule by the State Courts System is strictly to comply with Fiscal Year 2011-2012 Legislative Budget Request Instructions and should in no way be construed as an offer of reductions on the part of the courts. Clearly, such reductions as provided herein are not a viable alternative for the continued operations of the judicial branch and the State Courts System's trust funds' revenues are adequate to support and sustain our current base budgets within those trust funds through Fiscal Year 2011-2012. Therefore, reduction information is provided only in order to demonstrate the magnitude of the cut and to further explain how the judicial branch of government in Florida simply could not function with the resulting draconian cuts in court staff.

Due to previous cuts, the only place left for the State Courts System to meet the reduction targets is in the salary and benefits category which means eliminating FTE. The information provided herein reflects that impact. Nearly 45% (almost half) of the State Courts Revenue Trust Fund salary budget is dedicated to judicial salaries and benefits. In addition, General Revenue funding for the State Courts System is currently provided solely for a portion of judicial salaries in Circuit and County Courts. To assure Florida citizens of their constitutional right of access to the courts without sale, denial or delay, no reduction option is available to the courts in terms of reducing judicial officers. For this reason, and in order to describe the impact of the reduction, the reduction target for the General Revenue Fund is added to and reflected as a reduction in the State Courts Revenue Trust Fund. This increases the number of FTE to be reduced in the trial courts by an additional 126.25 FTE. The total number of 1,084.75 FTE (35% of staff) to be reduced, is clearly a staff reduction the judicial branch in Florida cannot sustain.

To paraphrase immediate past Florida Bar President Jesse Diner, in the worst of economic times, the courts play an ever more crucial role in stabilizing the economy by resolving disputes and establishing confidence not only in the courts but also in the institutions that rely on them.

Again, the impact of such a cut on Florida's economy is noteworthy as William Large, President of the Florida Justice Reform Institute, recognized in stating that companies are taking their business elsewhere because of legal backlogs in Florida: "Because of cuts to the judiciary in Florida, we are seeing Fortune 500 companies moving to Alabama and South Carolina."

The negative impact of further reducing court staff extends much further than the civil backlog. For example, as one circuit judge noted regarding the effect of reduced case managers on pro se litigants: "The first thing is we can't help them. There is confusion and the wrong things are filed. So there are delays and additional costs." For the appellate courts, a district court of appeal chief judge noted that further staff reductions could mean delays in terms of years or even decades in the disposition of cases.

The need for the establishment of a stable, reliable, dedicated funding source for the courts as a means of insulating the judicial branch from the vagaries of the economy was articulated by the branch in the Seven Principles of Court Funding. The 2009 Legislature, in special session, recognized the benefits of several of the principles and passed legislation increasing fee revenues, a majority of which they directed into a newly created State Court Revenue Trust Fund (SCRTF). Since that time, the percentage of the State Courts System budget funded by the SCRTF has risen to 79%. As stated earlier, the State Courts System's trust funds' revenues are adequate to support and sustain our current base budgets within those trust funds.
