

We are requesting the state to partner with Pinellas and Pasco County in supporting our ongoing Mentally Ill Jail Diversion Program in a special issue. This program has been in place since 2004 and has had remarkable success in reducing recidivism and providing treatment versus incarceration for clients admitted into the program. We are honored to have been recently awarded a \$750,000 grant to expand our program for the next three years, and have had ongoing county financial support.

If we are to reverse the trend through the country of our jails becoming mental health institutions, and effectively work to reduce budget shortfalls at both the county and state level, we must all work to provide alternate placements for those suffering from mental illness and substance abuse issues.
