This will allow the Program the greatest assurance that all Program representatives that meet with children have maintained a clean record. This calculation is based on the estimated 2,400 prints to be scanned in Fiscal Year 2010-11 that will be available in Fiscal Year 2011-12 for this service.

This funding was provided to keep more than 21 employees on the payroll to represent children in the foster care system. The recurring funding of this staff is critical to the mission of the Program. If the funding is not continued, the Program will be required to layoff more than 25 employees that represent children or support those employees representing children. The negative consequence of non-funding this issue would result in over 750 children not having representation in the foster care system.

The State Attorney, 1st Judicial Circuit is requesting re-approval of a Fiscal Year 2010-11 budget amendment numbered 11-037-SA01T, B0332. Approval was received on January 3, 2011 to implement an amended Victims of Crime Act (VOCA) grant. The total award of \$146,088 was for the one-year period from October 1, 2010 through September 30, 2011. Typically these VOCA awards are renewed annually. Approval of Grants and Donations Trust Fund authority in the amount of \$26,499 will be needed to implement this program from October 1, 2011 to June 30, 2012. Please reference issue code 2600130 for the amount needed to annualize funding. Should this authority not be granted, the State of Florida will lose funding that would provide critical services and assistance to the citizens of Florida.

The State Attorney's Office, 10th Judicial Circuit (SAO-10) has a contract with the Florida Department of Revenue (DOR) for these contracted services: To file legal actions and represent DOR in court actions involving Title IV-D cases to establish paternity orders; establish, enforce, and modify child and medical support orders; enforce spousal support when appropriate and provide other paternity and child and medical support case related legal services as requested by DOR in Polk, Hardee and Highlands Counties. SAO-10 has been performing Child Support Enforcement (CSE) for DOR in the 10th Circuit since 1997.

The contract between SAO-10 and DOR's CSE Unit has been amended to expand the CSE cases handled by SAO-10 to include "conflict cases," which were previously performed by an independent outside vendor. Recently, SAO-10 accepted 3,500 conflict cases from the previous vendor on DOR's behalf and is now representing DOR on these cases, in addition to the normal caseload. DOR has estimated that monthly caseloads will increase upwards of 250 additional conflict cases or another 3,000 cases annually. This is a significant collective caseload increase of 58 percent above current caseloads.

The instant increased workload requires two additional assistant state attorneys and two secretaries to prepare, file, maintain and catch up on backlogged cases. Four full-time equivalent (FTE) positions will need to be filled to keep up in the new, increased workload. The assistant state attorneys, who need to be hired, need to have experience in family law to handle "conflict cases." They cannot be hired right out of law school. The amended contract with DOR does not include an increase in funding. The current contract amount of \$1,186,779 provides enough funding to hire these four FTE. However, due to previous cuts and fund shifts, SAO-10 does not have enough Rate to cover salaries for the FTE.

The State Attorney's Office, Tenth Judicial Circuit is therefore requesting re-approval of Fiscal Year 2010-11 budget amendment number 11-131-SA10, P0048 which provided 129,680 in additional salary rate.

In Fiscal Year 2006-2007 this agency's budget request was approved under this special issue code for 6 positions to staff our Pinellas County Mentally III Jail Diversion Program, which has been operational since 2004 funded by a combination of federal, state and county funds. In 2007 we were therefore able to increase our Disposition Specialist staff working solely within our Jail Diversion program from 4 to 10 employees, thereby greatly enhancing the success of our jail diversion efforts (statistics follow). During Fiscal Year 2007 -2009, our budget was cut \$1,582,666, and we were forced to reduce staff throughout the office, which included a Disposition Specialist staff reduction from 10 to 6.

We are requesting funding, full-time equivalent (FTE) positions and accompanying rate for 2 Disposition Specialists" (Master's Level social workers) and 2 Disposition Specialists I (caseworkers) to replace those lost to budget cuts from 2007 to present. This will allow us to increase our jail diversion activities and expand our efforts into Pasco County, where these services are desperately needed. Since these are staff replacements, we do not request expense and human resource services assessments be added to this issue.

From 2004 through December 2009 (clients tracked through December 2010), our Jail Diversion Program served 2,984 clients, who had 12,985 arrests before Jail Diversion, and only 1,677 arrests after Jail Diversion, resulting in a remarkable 87% decrease in arrests for those admitted into the program. Additionally, 1,119 of these clients were never re-arrested

Our Jail Diversion program has been endorsed and is supported by Congressman C.W. "Bill" Young, Senator Mike Fasano, Representative Will Weatherford, the Sheriff of Pinellas and Pasco County, and the Board of County Commissioners of both Pinellas and Pasco County. This office recently received a three year DCF grant of \$750,000 to expand our jail diversion activities, and our funding requests have been approved for client services by both Pinellas and Pasco Counties. These funds will be used entirely for client services, and not staff. In order to address an expanding waiting list, we must staff our program. This is a proven method to reduce recidivism and ever increasing jail populations by providing treatment versus incarceration for our mentally ill clients and those who suffer from substance abuse issues, and thereby will effectively reduce budget shortfalls facing the State of Florida. This program exemplifies the Constitutionally mandated responsibility of this office ... to represent the indigent charged with a crime. If we are to effectively address the high cost of increasing jail populations, we must more effectively address the problem of mental illness and substance abuse that is so prevalent in our jails today.

NOTE: We are requesting this issue to be funded from General Revenue, due to the Governor's recommendation that ICDF trust funds be discontinued. If that does not occur, and if General Revenue cannot be approved, we would request that this issue be funded by ICDF trust funds with an accompanying increase in rate. This issue affects all of our agency activities.

Statewide turnover rate for public defender attorneys in FY 2009-10 was 15.80%. The Public Defender's Office of the Thirteenth Judicial Circuit's attorney turnover rate was at 30.73% in FY 2009-10. The percentage of attorneys retained with an average of three (3) or more years as of June 30, 2010 for this office is 53.03%, while the statewide retention for Public Defender's Offices is 61.64%. This level of lawyers leaving the offices of the Public Defender rises to the level of a constitutional crisis. The Public Defender's Office of the Thirteenth Judicial Circuit needs experienced criminal trial lawyers to represent indigent defendants charged with crimes. This loss of trained and experienced lawyers leads to cases being delayed while awaiting new lawyers to be assigned, who then must meet the client, familiarize themselves with the case, continue its preparation and ultimately resolve the case. The retention/incentive program for Assistant Public Defenders is to give every lawyer with three or more years experience within this office a \$5,000, non-recurring award on June 1, 2011. The calculation is based on 52.2 attorneys that average three or more years of service.

Beginning in fiscal year 2007-2008 the Office of the Public Defender, 18th J.C. was subjected to multiple budget reductions: the S/B 2-C Reduction, the 4% holdback, the Special Session Budget Reduction in January of fiscal year 2008/2009, a later reduction in fiscal year 2009/2010 and the last reduction in fiscal year 2010/2011 resulting in a difference of -\$2,306,036 in General Appropriation from the original appropriated amount of \$8,549,170 (FY 2006/2007) and the current FY 2010/2011 General Appropriation amount of \$ 6,243,134. Consequently this agency suffered seven (7) laid off employees in September 2009 in order to make payroll through the end of the fiscal year. Meanwhile each remaining Assistant Public Defender continually sustains the burden of the excessive caseload of the eight (8) vacant positions that the current Salaries and Benefits appropriation cannot support to fill. Due to legislative action, seven (7) positions were previously abolished but the caseload assignment continues and is again divided among the remaining Assistants. According to the Long Range Program Plan for FY 2011-2016 each attorney is currently assigned 520 cases whereas the Standard Caseload Assignment adopted by the Florida Public Defender Association is: three (3) Per Capital Felony; 200 Per Non-Capital Felony; 400 Per Misdemeanor and Criminal Traffic; 50 County to Circuit Court Appeal; and six (6) Per Sexually Violent Predator. This agency's goal in the Long Range Program Plan is to reduce the average number of cases assigned to an individual attorney from 520 to 423 by 2016. This small reduction in caseload assignment nevertheless is beyond the rudiments of criminal law whereas the principle responsibility mandated is to "effectively" represent an indigent client. The assignation to one legal representative of these overwhelming number of indigent individuals in need of representation and rightfully demanding personal attention distorts the original intent of and definition of "upholding each of these individual's constitutional rights" in a timely manner.
