The PSC is proposing the reduction of 3 FTE from the Utility Regulation budget entity. These reductions are being proposed as a result of the agency's initiative to gain efficiencies and streamline our processes. By eliminating these 3 FTE, the PSC will recognize a total reduction of \$216,535 from our recurring operating budget. At the time of this submission, all 3 positions are not vacant, however each position will be vacant by the effective date of this issue of July 1, 2012.
