The information provided electronically is a true and accurate presentation of our proposed Fixed Capital Outlay Legislative Budget Request of \$ 30,600.00 for the 2014-15 fiscal year.

Martin County, since the agency's inception, has offered the Office of Criminal Conflict and Civil Regional Counsel, 4<sup>th</sup> District, office space in the Martin County Courthouse for no fee. However, in September 2012, Martin County requested that the agency locate other office space due to the Supreme Court ruling in *Lewis v. Leon County*, 73 So.3d 151 (Fla. 2011), wherein the Court ruled definitively that the counties are not responsible to provide space or funding to the Regional Counsel agencies.

Accordingly, as of May, 2013, this agency will incur an increased expense for the rental of privately owned office space in Martin County. The current annual expense is \$30,600.00 and therefore, this agency has requested an increase in the annual allotment for building rental for privately owned buildings in that amount for the FY 2014-2015 Legislative Budget Request.
