2009-2010 BUDGET YEAR NARRATIVE:

The Division's existing SAN (shared network storage) and network backup hardware are six years old and have been "end-of-lifed" by the vendor and must be replaced before they break, which is consistent with the Division's general policy for replacing information technology equipment. Replacement of the current information technology infrastructure is crucial in order to provide continuity of service and avoid down-time for all of the Division's users. As the Division's e-filing capabilities and number of users increase, it is important to ensure that the system will continue to be up and running with minimal disruptions for maintenance and repair. Also, since the Division is the repository for agency final orders, the system must be operating at maximum capacity for the public to access all records maintained by the Division.

If this issue is not funded, the Division will have to utilize its base budget for information technology resources to replace its SAN. (The SAN houses all of the Division's imaged documents, including pleadings filed by parties and orders issued by Administrative Law Judges and Judges of Compensation Claims.) There will then be no funds available for other necessary information technology hardware such as servers, mini-towers, personal computers, etc.

The total cost of infrastructure replacement is \$143,046 and is divided evenly between the Division's two programs. If this issue is funded, the Adjudication of Disputes Program's overall operations will increase by \$71,523 (\$143,046 / 2). This program's budget is prorated among all state agencies that utilize its services. Hence, each state agency's proportionate share of the Division's FY 2009-10 budget will increase to cover the cost of replacing this equipment.

It is requested that \$71,523 be appropriated to purchase state-of-the-art equipment that has a serviceable lifespan, to be housed at the Division's headquarters in Tallahassee, Leon County, Florida. Implementation of the infrastructure replacement should be completed during the first quarter of FY 2009-10. Estimated costs are based on vendor quotes and include five years of support and maintenance. This issue is calculated as follows:

Pursuant to subsection 120.65, Florida Statutes, the Division of Administrative Hearings (DOAH) within the Department of Management Services shall be headed by a director who shall be appointed by the Administration Commission and confirmed by the Senate. The Division is a separate budget entity and is not subject to control, supervision, or direction by the Department of Management Services in any manner, including, but not limited to, personnel, purchasing, transactions involving real or personal property, and budgetary matters. The Director and Chief Judge of DOAH is its agency head for all purposes. All judges of the Adjudication of Disputes program, and the Deputy Chief Judge of Compensation Claims (Workers' Compensation Appeals program), report to the Director.

In corresponding issue #5006A10 for the Workers' Compensation Appeals program, the Division has requested that the salaries of judges of compensation claims be increased to \$133,020 per year, and the salary of the Deputy Chief Judge of Compensation Claims be increased to \$134,020 per year. This new salary structure is comparable to, but less than, the salaries of county court judges. It is therefore requested that the salary of DOAH's Director and Chief Judge be increased to \$135,020 per year, or \$1,000 more than the requested salary of the deputy chief judge that reports to him.

Prior to 1994, Section 440.45, Florida Statutes, tied the salary of a judge of compensation claims (JCC) to the salary of a circuit court judge. The 1993 legislature deleted this tie effective January 1, 1994, and since that time the salary of a judge of compensation claims has fallen well below the salary of other judges. If the circuit court tie was still in place, JCCs would be earning \$141,080 annually, or roughly 15% more than they are today. Since 1994, the circuit court judge salary has increased by 47%, the county court judge salary has increased by 56%, and the judge of compensation claims salary has increased by only 30%.

When appointed as judges of compensation claims, attorneys have no assurance that they will serve for more than their current four-year terms when they shut down their law practices. Judges of compensation claims work on cases generally more complex than those handled by county judges and as complex as most of what circuit judges normally handle. Thus, experienced judges of compensation claims routinely apply for appointments to the circuit and county courts because of the above salary disparity. In order to attract qualified applicants and retain quality judges, and to eliminate the salary disparity that has developed and grown over the last decade, it is requested that a link to the county court judge salary be established. To implement this tie, Section 440.45, Florida Statutes, should be amended as follows:

Paragraph (f) of subsection (2) of section 440.45, Florida Statutes, is added:

(2) (f) Effective July 1, 2009, each full-time judge of compensation claims shall receive a salary in an amount equal to \$4,000 less than that paid to a county court judge, and the deputy chief judge of compensation claims shall receive a salary in an amount equal to \$3,000 less than that paid to a county court judge. These salaries shall be paid out of the fund established in s. 440.50, Florida Statutes.

Establishing this link will increase the annual salary of a judge of compensation claims from \$122,564 to \$133,020 and the deputy chief judge of compensation claims from \$123,922 to \$134,020.

The total cost of this issue is \$395,721 as calculated below. The base rates used in the calculation correspond to the base rates for currently authorized (segment 1) positions. It impacts the "Adjudicate and Hear Workers' Compensation Disputes" Activity #ACT0511, which is conducted statewide. Approval of this issue will enhance the Division's efforts to attain its goal of improving the statewide adjudication process, as contained in its FY 2009-10 through FY 2013-14 Long-Range Program Plan.

The Office of the Judges of Compensation Claims (OJCC) currently has 32 career service executive secretary, 32 selected exempt deputy clerk and 30 career service administrative secretary positions in the district offices. These positions serve as assistants to the judges of compensation claims who are appointed officials, and therefore their job duties require a high level of responsibility and confidentiality. The OJCC loses many of these excellent support staff to county and circuit courts, law firms and municipalities that offer better compensation for similar positions. Since July, 2006, the turnover rate for these positions in the OJCC district offices has been 40%. The U.S. Department of Labor, Bureau of Employment Statistics' most recent data reflects an average turnover rate of 16.7% for government jobs.

The minimum annual salary for State of Florida deputy clerks and executive secretaries is \$25,479, and \$26,749 in designated south Florida counties. The county and circuit courts compensate their judicial assistants based on region. These minimum annual salaries range from \$29,320 to \$32,820 for county courts and \$30,540 to \$34,040 for circuit courts.

While it is impractical to increase the state employees' pay to match that of the county and circuit courts, a moderate increase in the base pay for these support positions would help the OJCC recruit and retain quality employees which will in turn improve the productivity and quality of the service provided by the OJCC. It is therefore requested that these support staff positions in the district offices receive an increase to their base pay amounts of 5% for administrative secretaries, 10% for executive secretaries, and 10% for deputy clerks.
