Addendum J of the Lease Agreement specifies that the Lessor is eligible for reimbursement of the unamortized portion of the \$2,500,000 expended for the lease improvements. At the time of termination & occupancy of a temporary tenant the unamortized portion is \$1,615,144.</p> <p>The unamortized amount is prorated at a maximum of \$13,889 a month with an annual total of \$166,667. The unamortized portion is adjusted when the space in the Northwood facility is occupied by a tenant.</p>
