The Division of Elections proposes that two current full-time Bureau of Voting Registration Services (BVRS) OPS employee positions be converted into two (2) Regulatory Specialist I positions. The Division proposes to fund the two positions by deducting \$40,387 each from the election fraud prevention category (104510) and the other personal services category (030000). The requested appropriation of \$80,774 from General Revenue will have a zero net effect. This appropriation transfer will enable the Division to more fully and efficiently use state resources and execute its statutory functions by using the new FTE positions to help protect the integrity of the electoral process by ensuring the maintenance of accurate and current voter registration records. The OPS positions have existed continually over the past year. The new FTEs would determine if information obtained about ineligible voters is credible and reliable so that the Division of Elections may notify the county supervisors of elections to undertake procedures for notice and possible removal of registered voters from the official Florida Voter Registration System. Two current OPS positions will be eliminated if the Regulatory Specialist I positions are approved.

Currently, the Department of State, Division of Elections, augments the current BVRS staff with Other Personal Services (OPS) employees. During general election years, BVRS increases to include 60 or more OPS employees and drafts other Departmental employees to assist with increased voter registration activities which in turn impacts activities related to identifying potentially ineligible registered voters. Even in non-election years, the BVRS uses several OPS employees to manage the workload. Since Florida's statewide voter registration system (FVRS) was instituted in 2006 and the BVRS undertook voter registration services activities relating to registration and eligibility maintenance, the average number of registered voters added to the rolls annually is 525,000. The number of total registered voters at any given time has increased from 10.5 million to almost 12 million.

The Department of State proposes to transfer three (3) FTE, two (2) positions (#00678 and #00430) from Office of the Secretary/ Administrative Services and (1) one position (#00228) from the Division of Library and Information Services to the Division of Historical Resources to create a unit dedicated to providing maintenance coordination and oversight to fifteen (15) Board of Trustees of the Internal Improvement Trust Fund properties leased to the Division of Historical Resources. The transfer of the three (3) positions will have a net zero effect. The properties are historically and/or archaeologically significant; three properties are listed as National Historic Landmarks. Located on these properties are thirty two (32) publically accessible structures utilized for museum exhibitions, visitor services, archaeological artifact conservation and administrative offices. Three properties are Native American archaeological sites with no structures attached.

The Division currently employs two (2) FTE at Mission San Luis solely responsible for site and facility management at the Mission. Repairs and maintenance of the remaining sites have been accomplished through contracted services coordinated by the Division of Historical Resources budget manager. Resources needed to support this function require training and skill in the development of repair and maintenance tasks, scopes of work, contractor quotes and contract management. The Division's current management of this function is no longer the best use of resources.

Additionally, two high profile properties in Tallahassee, The Grove and Hernando De Soto's Winter Encampment site will be receiving a high volume of visitors. Both of these sites will require concentrated repair and maintenance services. This proposal would consolidate and expand current staff to provide maintenance coordination and oversight for the properties. Services such as structural repairs, upkeep and maintenance, janitorial services, landscaping, lawn care and

The Underwater Archeologist III position would manage compliance with permits issued by the Division for survey and exploration activities to identify historical resources and for excavation and salvage activities to recover historical resources. This position is vital to ensuring the accurate recovery, conservation and transfer of objects recovered by commercial salvors under permit in exchange for recovery services provided to the state. The requirement for the Underwater Archeologist III position is included in Section 267, Florida Statutes and is consistent with state policy that all treasure trove, artifacts, and such objects having intrinsic or historical and archaeological value which have been abandoned on state-owned lands or state-owned sovereignty submerged lands shall belong to the state with the title vested in the Division for the purposes of administration and protection.

The Archeologist III position will be responsible for planning, coordinating and implementing an extensive range of state and federal regulations in order to ensure the integrity of Native American traditions. The Archeologist III position will be instrumental in developing a tribal network that will establish and encourage greater participation in the identification of direct kinship, tribal, community, or ethnic relationships with the individual or individual whose remains constitute the unmarked human burial. Statutory requirements for this position are included in Chapter 872, Florida Statutes and the Native American Graves Protection and Repatriation Act. The statutes require that the Division of Historical Resources may assume jurisdiction over and responsibility for an unmarked human burial in order to initiate efforts for the proper protection of the burial and the human skeletal remains and associated burial artifacts.
